CERTIFICATE OF INSURANCE

TO WHOM IT MAY CONCERN

THIS IS TO CERTIFY that insurance has been placed in the name of **JORDAN AVIATION** and their respective associated and affiliated and subsidiary companies as existing or as may be hereinafter constituted, for their respective rights and interests (the "Insured") and that we, **THE MEDITERRANEAN & GULF INSURANCE CO. P.L.C - JORDAN**, in our capacity as Insurer to the Insured have effected insurance, covering the Insured's aviation for their fleet of aircraft as specified herein, whilst operating anywhere in the World excluding Algeria, Burundi, Far North Region of Cameroon, Central African Republic, Democratic Republic of Congo, Ethiopia, Kenya, Mali, Mauritania, Somalia, The Republic of Sudan, South Sudan, Colombia, Peru, Afghanistan, Jammu & Kashmir, North Korea, Abkhazia, Ukraine, Crimea, Belarus, Donetsk & Lugansk regions of Ukraine, Nagorno-Karabakh, North Caucasian Federal District, South Ossetia, Iran, Libya, North Sinai Province of Egypt (including Taba International Airport), Syria, Yemen, Haiti, Israel, Niger and Burkina Faso and any country where the operation of the insured Aircraft is in breach of United Nations sanctions. However, coverage is granted for the over flight of any excluded country with the exception of Ukraine, Crimea, Belarus for which overflying is excluded where the flight is within an internationally recognised air corridor and is performed in accordance with International Civil Aviation Organisation recommendations), but Worldwide in respect of Products, against the following risks and up to the limits stated:-

AVIATION LEGAL LIABILITY covering the Insured's aircraft third party, passenger, baggage, cargo, mail and airline general third party legal liability for a combined single limit (bodily injury/property damage) of not less than USD 1,000,000,000 any one occurrence, each aircraft (including war and allied perils as excluded by AVN 48B (except sub-paragraph(s) (b) of AVN48B) in accordance with AVN 52E for a combined single limit (bodily injury/property damage) of not less than USD 1,000,000,000 any on occurrence, each aircraft), but in the annual aggregate in respect of products and war and allied perils legal liability.

NOTE: THE ABOVE AGGREGATE LIMIT(S) MAY BE REDUCED OR EXHAUSTED BY CLAIMS MADE IN RESPECT OF ANY INTEREST INSURED UNDER THE POLICY(IES).

INSURED AMOUNT: 100% (ONE HUNDRED PERCENT) of the coverage detailed.
